Travelling south on 165:

Follow I65 south to I10 west. Take I10W to exit 17a (which is route 193 south for the Dauphin Island/Tillman's Corner exit). Follow 193 south (also called Rangeline Road) for 6.1 miles to Evonik Road. Turn right on Evonik Road. The main gate for pedestrian visitors is approximately .9 miles on the right.

Travelling west on I10:

Take I10 west to exit 17a (which is route 193 south for the Dauphin Island/Tillman's Corner exit). Follow 193 south (also called Rangeline Road) for 6.1 miles to Evonik Road. Turn right on Evonik Road. The main gate for pedestrian visitors is approximately .9 miles on the right.

Travelling east on 110:

General Information

•Visitors must wear a hard hat and safety glasses with permanent side shields in all operation, maintenance, construction and "Work in Progress" areas.
